Release of Organizers and Sponsors

LEAGUE OF AMERICAN BICYCLIST ("LAB") RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in Battle Creek Bicycle Club ("Club") sponsored Cycling Activities ("Activity") I for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of Cycling Activities and that I am qualified to participate in such Activity. I further acknowledge that the Activity will be conducted over public roads and facilities open to the public during the Activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that: (a) BICYCLING ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURIES, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("Risks"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the conditions in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES I incur as a result of my participation in the Activity.

3. Ride Information:

Start/Finish: Full Blast Rec Center (downtown BC).
 35 Hamlin Ave, Battle Creek, MI
 Full Blast is located across the street from the Kellogg Arena and the McCamley Plaza Hotel.

Parking: at Full Blast and adjacent city lots.
 DO NOT park at the Battle Creek Post Office.

Routes: Routes of approx 31, 45, 62, and 100 miles will be offered for the CCC this year. We are also including a 10.5 mile loop around Battle Creek on the linear path. This short loop will be very family friendly. We will travel to Marshall from Battle Creek to Stuart's Landing for the lunch break. These routes are mostly in Calhoun County. The century metric century will visit areas East and North of Battle Creek. The areas North of Battle Creek will feature a few rolling hills in a scenic setting.

FREE FOOD!

New for 2008 will be a carbo loading meal on Saturday evening prior to the century. This will be included with a paid registration. Bring your receipt of registration or register at the dinner. Location will be added to the web site in a few weeks. "Please" r.s.v.p. to bikerider@battlecreekbicycleclub.org if you plan to attend. See the bike club web site for final location with directions.

Facilities: Restrooms will be available at all rest areas and registration. Showers will be available at the registration/finish site - Full Blast Rec Center. Bring your own towel.

Early Registration: Registration by mail must be postmarked before Sept 1, 2008, to qualify for the \$15.00 entry fee (individual) or \$20.00 (family). All riders registering after Sept 1, 2008, will need to pay \$20.00 (individual) or \$40.00 (family).

Day of Registration: Registration will open at 6:30 a.m. of the DOE - Sunday, Sept 14, 2008. Registration will close at 10:00. Century riders, please depart by 10:00 a.m..
